

TERMS & CONDITIONS

RM20 cashback with RM100 spend per month @ O'Brien's

Duration

1. "RM20 cashback with RM100 spend per month campaign" is organised by OCBC Bank (Malaysia) Berhad ("OCBC Bank") and is subject to these terms and conditions. The Campaign runs from 9 August 2018 to 9 October 2018. ("Campaign Period").

Eligibility

2. The Campaign is open to all OCBC Credit and/or Debit Card Cardmembers (principal and supplementary Cardmember) who hold an OCBC Credit and/or Debit Card issued in Malaysia (collectively "Cardmembers").
3. Cardmembers who meet and fulfil the Campaign Criteria below shall be referred to as an Eligible Cardmembers ("Eligible Cardmembers").

Campaign Criteria

4. No registration is required. Eligible Cardmembers are required to fulfil a minimum retail spending (define below) of RM100 cumulatively in a month using the OCBC Credit and/or Debit Card during the Campaign Period. Upon meeting and fulfilling clause 4 and clause 5 stated herein Cardmembers shall be referred to as an Eligible Cardmembers.
5. Retail spending is defined as below:
 - (a) Any retail purchases at the following O'Brien's outlets:
 - Menara OCBC, GE Mall, 1 Utama, KLCC, Holiday Inn Express, Empire Subang Mall

Cashback

6. Eligible Cardmembers who fulfil clauses 4 and 5 above will stand a chance to be rewarded with a RM20 cashback
7. There will be a total cap of 350 cashback on a first come first serve basis throughout the campaign period. Up to RM7,000 worth of cashback throughout the campaign period.
8. Subject to the terms and conditions set out herein, each eligible cardmember is entitled to a maximum of one (1) cashback per month.
9. There is a capping amount of RM7,000 of CashBack throughout the campaign period.
10. All transactions will be calculated from 00:00 hours to 23:59 hours (Malaysia time) during the campaign period. The date and time of the transactions are based on the transaction time as captured by OCBC Bank during Campaign Period.
11. OCBC Bank shall not be responsible for any failure and/or delay in the transmission of evidence of sales transactions by any merchant(s) or any other party.
12. Eligible cardmembers will be selected on a first come first serve basis by system upon spending more or equal of RM100 within a calendar month.
13. CashBack awarded are non-transferable to any other party or parties and not exchangeable for other items or vouchers in part or in full.

14. The CashBack will be credited into the respective eligible cardmember's OCBC credit card account. The crediting of the CashBack will be reflected in the eligible cardmember's credit card statement of the following month.
15. At the time of awarding the CashBack, the eligible cardmember's credit card account(s) must be current, valid, subsisting and in good credit standing as may be determined by OCBC Bank at its sole and absolute discretion, and not in breach of any of these terms and conditions.
16. OCBC Bank reserves the right:
 - (a) To forfeit the CashBack if there is a reversal of a retail transaction or termination of the eligible cardmember's Card prior to the CashBack being given to the Winners, or non-compliance or breach of these terms and conditions.

General Terms & Conditions

17. OCBC Bank's decisions on all matters relating to this Campaign shall be final, conclusive and binding. OCBC Bank shall not be obliged to give any reasons whatsoever or enter into any correspondence with any person(s) on any matter concerning the Campaign.
18. OCBC Bank reserves the right to use any information, names and photographs of the Winners for publishing in any mass media or marketing materials for advertising or publicity purposes.
19. OCBC Bank reserves the rights at its absolute discretion to withdraw, cancel, suspend, extend or terminate this Campaign either in whole or in part, or to vary, delete or add to any of the terms and conditions herein at any time with prior notice.
20. OCBC Bank shall not be liable for any misinterpretation of facts in respect of the Campaign published in any mass media, marketing or advertising materials.
21. In the event of any inconsistency between these terms and conditions and any advertising, campaign, publicity and other materials relating to or in connection with the Campaign, these terms and conditions shall prevail.
22. This Campaign is not applicable in conjunction with any of OCBC Bank's ongoing promotions unless otherwise stated.
23. The OCBC Cardmember's Agreement shall continue to apply to usage of OCBC Bank credit cards. In the event of any inconsistencies between these terms and conditions and the terms and conditions in the OCBC Cardmember's Agreement, these terms and conditions shall prevail only insofar as they apply to this Campaign.
24. These terms and conditions shall be governed by the laws of Malaysia, and Cardmembers who participate in the Campaign shall be deemed to have agreed to submit to the exclusive jurisdiction of the Malaysian Courts.
