b) Although the Bank will endeavour to effect such periodic payments it accepts no responsibility to make the same and accordingly the Bank shall not incur any liability through any error refusal or ommision to make all or any of the repayments or by reason of late payment or by any ommision to follow any such instruction.

c) This mandate is subject to any arrangement now subsisting or which may hereafter subsist between myself and the Bank in relation to my account or any banking accommodation afforded to me.

d) The bank may at it's absolute discretion conclusively determine the order of priority of payment by it of any moneys pursuant to this or any other order or cheque which heretofore or may hereafter give to the Bank or draw on my account.

e) The Bank may at it's absolute discretion terminate this mandate as to future payments at any time by notice in writing to me or without notice at any time after being advised by the Centre that no further payment is required or if the Bank deems it to be in its interest or without assigning any reason therefore.

f) This mandate will remain effective for the protection of the Bank in respect of payments made in good faith notwithstanding my death or bankruptcy or the revocation of this mandate by any other means until written notice of my death or bankruptcy or of such revocation is received by the bank.

g) A charge of RM or any subsequent rate of charges that may be made from time to time will be levied for each periodic payment effected by the bank. This charge does not include any incidental postage and/or stamp duty and inland exchange, etc which may also be applicable.

h) The Bank may levy a charge on all standing instructions on due dates which may not be refunded even if the instruction is not effected for insufficient funds.

i) In the event that payment cannot be made to the Centre due to insufficient funds in the account, the bank shall not effect payment for the payment concerned. I shall make alternative arrangements to effect such payment concerned.
