AKHMAL ASYRAF'S UNIQUE ART TO "HARMONIZE" WITH OCBC AL-AMIN XPRES BRANCH AT AMPANG PARK LRT

KUALA LUMPUR, 26 May 2014 – OCBC AI-Amin Bank Berhad (OCBC AI-Amin) has linked arms with up-and-coming artist Akhmal Asyraf to have his *Harmonize* collection of mixed media Pop art displayed on the walls of the Bank's Ampang Park LRT branch.

Akhmal's mixed media works from the *Harmonize* collection, including the eyecatching *There Are Some Remedies* and *Mesmerize*, are on display at the exhibition area inside the branch and on the outside walls as well.

According to Seremban-born Akhmal his works are based on his own reflections on, and experiences of, the rapid development around him. His works involve recycled materials that are re-fashioned into intriguing pieces of art including mixed media collage on wood with elements of Pop styles.

"I'm thrilled at the opportunity to have my works displayed at a high traffic area like the OCBC Al-Amin Xpres branch at the Ampang Park LRT station. My deepest gratitude to OCBC Al-Amin for making this possible," said the 26-yearold UiTM graduate of fine arts.

Commenting on the collection, OCBC Al-Amin's Head of Consumer Financial Services, Dzulkifly Aminuddin said what is particularly exciting about this collaboration is the opportunity it affords for the Bank to provide aspiring young artists like Akhmal a creative outlet to display their art for the masses, especially young working adults.

"We're happy to make this connection. Akhmal's strength lies in his ability to imbue meaning based on current social realities while tracing Pop art in the highly individualised fashioning of each piece. His attention to detail is so great that you can almost imagine being whisked away to the good old days when life was simple and advertising was still in its infancy. In the old days when computers were not the mainstream means of communication, artists were employed to draw and paint advertisements, instead of relying on computergenerated images and special effects in ways many advertising companies do today," he said.

Dzulkifly added that the Bank is seeking to reach out to more young working adults and youth through its *OCBC Al-Amin Xpres* branches and one of the ways is through visually attractive paintings such as Akhmal's.

"On the business front, we expect our approach to banking at OCBC Al-Amin *Xpres* to resonate with young working adults, especially working professionals, who are looking for simplicity and convenient locations at which to do their banking even outside regular banking hours," he said.

OCBC AI-Amin Xpres was launched in 2012, the latest addition being the one at the Ampang Park LRT which opened in June 2013.
