1. When must I start to use the new trade application form?

Effective Jan 2017, OCBC Bank will no longer accept trade applications using the old forms.

2. How do I know whether I am using the new or old trade application form?

To find out whether the form that you are using is the latest version, kindly refer to the page-footer at the bottom of the page. All OCBC Bank or OCBC Al-Amin Bank trade application forms have been revised on 19 May 2016.

4. When would the new softcopy of trade application forms be enforced?


The new forms will be enforced from 1 January 2017. However, customers are encouraged to start using the new trade application forms even before 1 January 2017.

Your application may be rejected / delayed until you resubmit the new trade application form.
