

Revision on OCBC Credit Card Terms and Conditions on the list of transactions excluded for cashback and Voyage Miles calculation

We have updated the OCBC Credit Card Terms and Conditions on the list of transactions that are excluded for cashback and Voyage Miles calculation, as listed below. This update will take effect from 20th January 2023 onwards.

Current list of transactions excluded for cashback and Voyage Miles calculation

The transactions below are excluded for cashback calculation:

- (i) Easy Payment Plan (EPP)
- (ii) Balance Transfer (BT)
- (iii) Call for Cash (CFC)
- (iv) Power Credit Cash Plus

- (vii) Finance charge
- (viii) Annual fee

- (x) Reversal on transaction

The transactions below are excluded for Voyage Miles calculation:

- (i) Card facilities such as Balance Transfer, Cash Plus, Cash on Card, Call for Cash, Instalment Payment Plan, Easy Payment Plan, and Cash Advances
- (ii) All fees, charges, interests, penalties and others incurred under the Card facilities referred to in the preceding sub-paragraph
- (iii) Reversed transactions, fraudulent transactions, disputed transactions
- (iv) Income tax payment
- (v) Finance and late payment charges
- (vi) Service tax
