

Revision on OCBC Credit Card Terms and Conditions on the list of transactions not eligible for rewards calculation and auto-IPP

We have updated the OCBC Credit Card Terms and Conditions on the list of transactions that are excluded for cashback, Travel\$ and Voyage Miles calculation as well as for Auto-Instalment Payment Plan (Auto-IPP), as listed below. This update will take effect from 20th July 2023 onwards.
