TERMS & CONDITIONS

Total Prizes of RM200,000 Cashback & 500,000 Enrich Miles To Be Won

Duration

1. The "Total Prizes of RM200,000 Cashback & 500,000 Enrich Miles To Be Won" ("Campaign") is organised by OCBC Bank (Malaysia) Berhad ("OCBC") and is subject to these terms and conditions. The Campaign runs from 15 October 2018 till 31 December 2018 ("Campaign Period").

Eligibility

- 2. The Campaign is open to OCBC Credit and Debit Card Principal Cardmembers who hold an OCBC Credit or Debit Card issued in Malaysia (collectively "Cardmembers").
- 3. Cardmembers who meet and fulfill the Campaign Criteria below shall be referred to as Eligible Cardmembers ("Eligible Cardmembers").
- 4. The following persons are **NOT** eligible to participate in this Campaign:-

Registration

- 5. To participate in the Campaign, Eligible Cardmembers are required to register (one-time basis) with OCBC within the Campaign Period via any of the following methods:

SMS Registration

- 6. SMS sent out by Cardmembers to 62662 for registration purpose shall be deemed as consent to participate in this Campaign.
- 7. Standard Telecommunication Operator's (Telco) network charges will apply to each SMS sent.
- 8. Proof of SMS sent does not proof of successful registration. The Bank shall not be liable and responsible for any unsuccessful registration due to network failure and/or interruption experienced by the respective Telco.
- 9. Cardmembers will receive a confirmation SMS from the Bank's appointed SMS vendor upon successful registration within 48-hour and such confirmation SMS will be sent to the same mobile phone used for registration.

Online Registration

- 10. Cardmembers who register via online at Campaign Website shall be deemed to have consented to participate in this Campaign.
- 11. Cardmembers will receive a confirmation of successful registration from OCBC shown on the Campaign Website.

Campaign Criteria

12. A minimum of RM50 must be spent with an OCBC Credit or Debit Cards to gain an entry. Different spending categories will provide Eligible Cardmembers with a different number of entry or entries.

Cashback

- 13. Eligible Cardmembers who fulfill the above-mentioned campaign criteria will stand a chance to win a RM50 weekly cashback. A maximum of 4 X RM50 cashback will be given out per month per cardmember.
- 14. Eligible Cardmembers who fulfill the above-mentioned campaign criteria will stand a chance to win a RM500 monthly cashback. A maximum of 1 X RM500 cashback will be given out per month per cardmember.

Enrich Miles (EM)
