TERMS & CONDITIONS Weekly Samsung S10 Giveaways

Duration

1. The "Weekly Samsung S10 Giveaways" ("Campaign") is organized by OCBC Bank (Malaysia) Berhad ("OCBC") and is subject to these terms and conditions. The Campaign runs from 1 April to 30 June 2019 ("Campaign Period").

Eligibility

- 2. The Campaign is open to OCBC Credit Principal Cardmembers and Debit Cardmembers who hold an OCBC Credit or Debit Card issued in Malaysia (collectively "Cardmembers").
- 3. Cardmembers who meet and fulfill the Campaign Criteria below are referred to as Eligible Cardmembers ("Eligible Cardmembers").

Registration

- 5. To participate in the Campaign, Eligible Cardmembers are required to register (one-time basis) with OCBC during the Campaign Period via the following method:

Online Registration

- 6. Cardmembers who register online at the Campaign Website are deemed to have consented to participate in this Campaign.
- 7. Cardmembers will receive a confirmation of successful registration from OCBC shown on the Campaign Website.

Campaign Qualifying Criteria

- 8. Every RM50 spent on eligible transactions with an OCBC Credit or Debit Card will gain an entry or entries. Refer to Table B below for how this is tabulated.
- 9. Any retail transactions by the Supplementary Cardmember(s) under the same Eligible Cardmember's Credit Card account will be included in the computation of the Eligible Cardmember's cumulative retail spending;

 - a) Existing recurring Easy Payment Plan & Interest Payment Plan (for OCBC Credit Cards)

Prizes & Winners' Selection

- 15. Eligible transactions will be calculated from 00:00 hours to 23:59 hours (Malaysia time) on each Weekly Draw throughout the Campaign Period. The date and time of the transactions are based on the transaction time as captured by OCBC globally during the Campaign Period.
- 16. The eligible entry(s) earned during the respective Weekly Draw will not be carried forward to the next Weekly Draw and shall duly be reset to zero.
- 17. Winners shall be randomly selected by an automated selection system based on the entries earned by Eligible Cardmembers during the Campaign Period
- 18. Subject to the terms and conditions herein, OCBC's automated system will generate three (3) potential winners for each Participating Week referred to under Clause 14 herein based on the total entries earned during each Participating Week ("Potential Weekly Prize Winner(s)"). - 24. Winners shall be responsible to ensure that their telephone numbers and/or email address and/or mailing address provided are current and updated with OCBC. The delivery of the Prizes is only valid for mailing addresses that are based within Malaysia, and will not be valid for mailing address that is based outside Malaysia.
