Terms and Conditions

To enjoy the offer, Cardmember must call Voyage Exchange to make the dining reservation. Payments must be made with an OCBC Premier Voyage MasterCard. Each Cardmember is limited to participating only once in a month and the rebate is capped at RM200. The rebate is based on the total spending in a single receipt at any dining establishments in Malaysia except drinking places (alcoholic beverages), bars, taverns, cocktail lounges, nightclubs and discotheques. The rebate will be processed on a first come, first served basis and subject to the Campaign Capping of RM50,000.

TERMS AND CONDITIONS

THE CAMPAIGN

1. The "Dining Offer" ("Campaign") is organised by OCBC Bank (Malaysia) Berhad ("OCBC Bank") and runs from 1 June 2017 to 31 December 2017, both dates inclusive ("Campaign Period").

ELIGIBILITY

- Subject to these Terms and Conditions, only customers of OCBC Bank, who meet the criteria set out in both (a) and (b) below are eligible to participate in this Campaign (each as an "Eligible Cardmember" or collectively as "Eligible Cardmembers"):
 - a) Customers who hold an OCBC Premier Voyage credit card ("OCBC Premier Voyage Card") issued by OCBC Bank in Malaysia; and
 - b) Customers whose credit card accounts maintained with OCBC Bank are in good standing according to OCBC Bank's sole definition and absolute discretion.
- 3. Customers whose accounts with OCBC Bank have been suspended or terminated or who have breached any other agreements with OCBC Bank at any time during the Campaign Period are not eligible to participate in this Campaign.
- 4. OCBC Bank reserves the right to disqualify any Eligible Cardmember who becomes ineligible (as mentioned in clause 3) any time during the Campaign Period from continued participation in this Campaign.
- 5. To participate, an Eligible Cardmember must:
 - a) Make the relevant bookings or reservations through OCBC Bank's appointed concierge service, namely Voyage Exchange; and
 - b) Make the payment using his or her OCBC Premier Voyage Card.

THE CAMPAIGN MECHANICS

- 6. Upon meeting the criteria in clauses 5(a) and 5(b) above, an Eligible Cardmember will enjoy a 20% rebate on his or her dining, subject to clauses 8 and 9 below ("Dining Offer").
- 7. Each Eligible Cardmember is limited to participating only once in a month.
- The Campaign to be granted to Eligible Cardmembers is capped at an overall total of RM50,000 ("Campaign Capping").
- 9. The Eligible Cardmembers who perform as required in clauses 5(b) and 5(b) will be processed on a first come, first served basis and subject to the Campaign Capping.

- 10. The Dining Offer is applicable to dine-in meals only and is based on the total spent in a single receipt at any dining establishments in Malaysia (except drinking places (alcoholic beverages), bars, taverns, cocktail lounges, nightclubs, and discotheques), subject to the dine-in transaction being completed within the month that Eligible Cardmember make the dining reservation. ("Eligible Spend").
- 11. Under the Campaign, the Eligible Cardmember shall call Voyage Exchange to make the dining reservation by providing, at the very least, the name of a restaurant as stated in Table A below and date of the scheduled visit in advanced. The Eligible Cardmember shall be eligible to receive the Dining Offer for the amount that is charged and debited to his or her OCBC Premier Voyage Card account ("Card Account") during the Campaign Period in any Eligible Spend Categories set out in the first column of Table A below at the outlets under the Merchant Category Code ("MCC") set out in the second column of Table A below.

- 12. The MCC set out in Table A above includes all dining establishments in Malaysia except drinking places (alcoholic beverages), bars, taverns, cocktail lounges, nightclubs, and discotheques.
- 13. The Eligible Cardmember has to pay the bill in full by using his or her OCBC Premier Voyage Card during the meal and the Dining Offer will be credited into his or her Card Account within two (2) months from the month the Eligible Spend was made. This will be reflected in his or her monthly statement.
- 14. The Eligible Spend made during the Campaign Period must be captured by the credit card system maintained by OCBC Bank in order to qualify for participation in the Dining Offer.
- 15. The Dining Offer is capped at RM200 for each Eligible Cardmember.
- 16. The Dining Offer is not transferable to any other party or parties and not exchangeable for other goods.
- 17. At the time the Dining Offer is credited to the Eligible Cardmember, the Card Account must be current, valid, subsisting and in good credit standing as may be determined by OCBC Bank at its sole and absolute discretion and not in breach of these terms and conditions and/or any of the terms and conditions contained in any other agreements with OCBC Bank.
- 18. In the event that the first dining reservation is cancelled or the Eligible Cardmember does not turn up, the Eligible Cardmember will still be eligible for the Dining Offer for his or her subsequent dining reservation made through Voyage Exchange within the month that Eligible Cardmember make the dining reservation, during the Campaign Period.
- 19. In the event that more than one (1) dining reservations are made by the Eligible Cardmember within the month that Eligible Cardmember make the dining reservation during the Campaign

Period, the Dining Offer will apply only to the first Eligible Spend the Eligible Cardmember has made.

20. The Dining Offer is still bound by the terms and conditions of the respective merchants, if any.

GENERAL TERMS AND CONDITIONS

- 21. By participating in this Campaign, Eligible Cardmembers agree and consent to their personal data being collected, processed and used by OCBC Bank for the purposes of the Campaign.
- 22. OCBC Bank reserves the right to forfeit the Dining Offer in the event there is a reversal of transaction entry or cancellation or termination of the Eligible Cardmembers' Premier Voyage Card during the Campaign Period or non-compliance or breach of these terms and conditions of the OCBC Credit Cards Cardmember's Agreement with prior notice without assigning any reason.
- 23. OCBC Bank reserves the right to select Eligible Cardmembers on its reserve list to substitute any disqualified Eligible Cardmembers as mentioned in clause 4. OCBC Bank's determination shall be final, conclusive and binding. No correspondence or claims shall be entertained.
- 24. By participating in this Campaign, an Eligible Cardmember agrees to be bound by these Terms and Conditions. OCBC Bank's decision on all matters relating to this Campaign shall be final, conclusive and binding. OCBC Bank shall not be obliged to give any reason whatsoever or enter into any correspondence with any person(s) on any matter concerning the Campaign.

OCBC Bank reserves the rights to withdraw, cancel, suspend, substitute, extend or terminate this Campaign earlier in whole or in part, or to vary, delete or add to any of the terms and conditions herein at any time with prior notice. Notice of such variation of the terms and conditions or suspension or termination of the Campaign is deemed given through a general notice being posted in any OCBC Bank branch or OCBC Bank website and the notice will take effect from the date set out in the notice and, if no date is stated, will take effect from the date the notice is posted.
- 26. OCBC Bank shall not be liable for any misinterpretation or misrepresentation of facts in respect of the Campaign published in any mass media, marketing or advertising materials that are not controlled or issued by OCBC Bank.
