

Terms and Conditions – "Cash Financing-i EPF Fast Approval Promotion"

- 1. OCBC Al-Amin Bank Berhad's ("Bank") "Cash Financing-i EPF Fast Approval Promotion" ("Promotion") runs from 25 February 2013 to 31 March 2013 (both dates inclusive) ("Promotion Period").
- 2. **Eligible Customers**: All Cash Financing-i customers of the Bank are eligible to participate in this Promotion subject to the following conditions:
 - a. The Cash Financing-i customers must reside in Klang Valley;
 - b. The Cash Financing-i customers' EPF statements (must be printed from OCBC Branch, OCBC Al-Amin Branch or OCBC Al-Amin Xpres Branch with "Penyata ini dicetak di OCBC <location of the branch>") have been submitted as income reference document for Cash Financing-i application; and
 - c. The Cash Financing-i applications must have been approved and disbursed within Promotion Period.
- 3. The following persons are not eligible to participate in this Promotion:
 - a. The Bank's customers who have early-settled their Cash Financing-i within the Promotion Period or whose financing or other accounts with the Bank and/or OCBC Bank (Malaysia) Berhad ("OBMB") are not in good standing and / or are in breach of any of the Bank's or OBMB Terms & Conditions;
 - b. employees and agents of the Bank, OBMB and e2 Power Sdn Bhd including their respective family members; and
 - c. customers whose accounts with the Bank/OBMB have been suspended or terminated or who have breached any other agreement with the Bank/OBMB.
- 4. The Bank shall not be held liable for any delay or alleged delay in the turnaround time for approval or disbursement.
- 5. No pre-registration, SMS or contest entry forms are required.
- 6. Under this Promotion, the first 60 Eligible Customers ("Winners") will be rewarded with buffet dining voucher (Prizes) at The Westin Kuala Lumpur (Hotel).
- 7. Winners will be notified via SMS or telephone call within 2-3 weeks after the end of the Promotion Period.
