

OCBC Bank Magic Moments 360 Account Promotion

Terms and Conditions

1. The Promotion

- 1.1. OCBC Bank Malaysia Berhad (295400-W) (“OCBC Bank”) presents the **OCBC Bank Magic Moments 360 Account Promotion** (“Promotion”) subject to the terms and conditions herein.
- 1.2. The Promotion runs from **17 May until 31 August 2017**, both dates inclusive (“Promotion Period”), or such other date(s) as may be determined at the sole and absolute discretion of OCBC Bank for the relevant product(s) offered in this Promotion.
- 1.3. The Promotion is only available at the OCBC Bank branches in Malaysia.

2. Eligibility

- 2.1. The Promotion is open only to individual Malaysia residents, Permanent Residents and non-residents. *Non-residents whose country of origin is not acceptable to OCBC Bank shall not be eligible to participate in this Promotion.*
- 2.2. Customers shall be and shall remain in good standing according to OCBC Bank’s absolute discretion, to be eligible for participation or continued participation in this Promotion. Customers whose accounts with OCBC Bank and/or OCBC Al-Amin Bank Berhad have been suspended or terminated or who have breached any other agreements with OCBC Bank and/or OCBC Al-Amin any time within the Promotion Period are not eligible to participate, or to continue to participate, in this Promotion.
- 2.3. Customers who fulfilled clauses 2.1 to 2.2 above are eligible to participate in this Promotion and shall be referred to as “Eligible Customers”.

3. Promotion Mechanics and Conditions

- 3.1. An Eligible Customer must do the following as per the details in Table (1) with OCBC Bank during the Promotion Period to be eligible for a chance to win a Prize (as defined below) (“Eligible Participant”).
