

TERMS & CONDITIONS

OCBC - VIVO COMPLIMENTARY 1 MONTH IPP & EARBUDS CAMPAIGN

Duration

1. The “OCBC x vivo Complimentary 1 Month IPP Campaign” (“Campaign”) is organised by OCBC Bank (Malaysia) Berhad (“OCBC Bank”) and is subject to these terms and conditions. The Campaign runs from 14 May 2022 to 13 June 2022, both dates inclusive (“Campaign Period”).

Eligibility

2. This campaign is open to all OCBC Principal and Supplementary Credit Cardmembers who hold OCBC Credit Card(s) issued by OCBC Bank (collectively referred herein as “Eligible Cardmember(s)”).

6. For the avoidance of doubt:
- Purchase of the Eligible vivo Phone(s) and/or application of the Plan at other concept stores other than the participating vivo concept stores that are listed in Clause 5 above; and/or
 - Purchase of the Eligible vivo Phone(s) and/or application of the Plan via online; and/or
 - Purchase of the Eligible vivo Phone(s) via any other methods other than those stated in Clauses 4 and 5 above

will not be eligible for this Campaign and its Campaign Rewards.

- The tracking of the Campaign Criteria is based on the dates and time (Malaysian Time) as captured by OCBC Bank's records during the Campaign Period.
- OCBC Bank shall not be responsible for any failure and/or delay in the transmission of evidence of sales transactions by vivo and/or any other party.

Campaign Reward Fulfilment Process

12. At the time of Campaign Reward fulfilment, the Eligible Cardmember's Credit Card account must be current, valid, subsisting and in good credit standing as may be determined by OCBC Bank at its sole discretion, and not in breach of any of these terms and conditions.

13. a) The Campaign Reward (Cashback) will be credited into the respective Eligible Cardmember's OCBC Credit Card account by OCBC Bank within seven (7) working days after the transaction has been posted.

Eligible Cardmembers shall be responsible to ensure that their telephone numbers and/or email address and/or mailing address provided are current and updated with OCBC Bank. The notification of the Cashback will be based on each Eligible Cardmember(s)' telephone numbers and/or email address and/or mailing address in Malaysia maintained with OCBC Bank.

- b) The Campaign Reward (vivo Earbuds) will be delivered to Eligible Cardmember's preferred address (to be provided by Eligible Cardmember upon checkout) by the Supplier within seven (7) working days from the date of purchase. The delivery of the vivo Earbuds will be made by the Supplier and as such will be the party collecting Eligible Cardmembers' personal data to facilitate the delivery of the vivo Earbuds. Eligible Cardmembers' personal data will be subject to the Supplier's privacy policy. OCBC Bank shall not be responsible for (i) any issue relating to any vivo products and services of the Supplier; and (ii) any loss or damage sustained by the Eligible Cardmembers in connection with such vivo products and Supplier services.

14. The Campaign Reward cannot be transferred to a 3rd party, exchanged for cash or a different prize or reward of similar value or any other alternatives in any circumstances.
15. OCBC Bank reserves the right to forfeit the Campaign Reward if (1) there is a termination of the Eligible Cardmember's Card prior to fulfilment of the Campaign Reward to the Eligible Cardmember; or (2) any noncompliance or breach of these terms and conditions by the Eligible Cardmember.

General Terms & Conditions

16. OCBC Bank reserves the rights at its sole discretion to withdraw, cancel, suspend, extend or terminate this Campaign either in whole or in part, or to vary, delete or add to any of the terms and conditions herein at any time with prior notice.
17. The vivo phones are marketed and distributed by vivo Sdn Bhd ("Supplier"). The Supplier will not accept any refund or return. If the Eligible vivo Phone and/or vivo Earbuds is/are found faulty, Eligible Cardmember is required to visit vivo's service centre for checking. If issues arise due to manufacturer defect, repair or replacement will be decided at the Supplier's discretion. Any dispute in connection with the vivo phone or vivo Earbuds shall be referred to the Supplier.
18. OCBC Bank does not make and expressly excludes and disclaims any representation and warranty in relation to the vivo phones, vivo Earbuds, any vivo products and the Supplier. In particular, OCBC Bank gives no warranty or endorsement in respect of the vivo phones, vivo Earbuds and any vivo products, including but not limited to any warranty on merchantability quality or suitability or fitness for any purpose. OCBC shall not be responsible for any damage, defect or deficiency in any vivo products and/or any loss, injury, damage, harm or accident of whatever nature suffered or sustained by anyone in connection with any vivo products howsoever arising.
19. The OCBC Bank Cardmember's Agreement shall continue to apply to usage of OCBC Credit Cards in the event of any inconsistencies between these terms and conditions and the terms and conditions in the OCBC Cardmember's Agreement, these terms and conditions shall prevail only insofar as they apply to the Campaign.
20. These terms and conditions shall be governed by the laws of Malaysia, and Eligible Cardmembers who participate in the Campaign shall agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
21. All Eligible Cardmembers by participating in the Campaign are deemed to have:
 - a) voluntarily provided their personal data to the Supplier and consented to the Supplier to process their personal data in accordance with such terms and conditions imposed by the Supplier and privacy policy of the Supplier for which the Eligible Cardmembers will make enquiry with the Supplier;
