

# Terms and Conditions governing the OCBC x Accounting Software Provider Campaign 2026

## 1. The Campaign

The **OCBC x Accounting Software Provider Campaign** (“Campaign”) is organized by OCBC Bank (Malaysia) Berhad 199401009721 (295400-W) (“OCBC Bank”) and OCBC Al-Amin Bank Berhad 200801017151 (818444-T) (“OCBC Al-Amin”) (collectively referred to as the “Bank”) and runs from 1 Apr 2026 to 30 Sep 2026 (both dates inclusive) (“Campaign Period”).

## 2. Eligibility

2.1 The following are eligible to participate in this Campaign:

- (a) Any customers of the Bank which are companies or businesses, participation in this Campaign is by invitation only.

Each company or business entity which is eligible under this clause and does not come under clause 2.2 below, is referred to as an “Eligible Customer”.

2.2 The following are not eligible to participate in this Campaign:

- (a) Any customer which breaches any of its obligations or agreements with the Bank.

## 3. Campaign mechanics

3.1 Each of the **first 150** Eligible Customers who subscribe, upgrade, or perform software maintenance (“Accounting products and services”) from any of the participating accounting software providers listed below (“Accounting Software Providers”) within the Campaign Period will be eligible to receive the cash rebate of **RM400** on a first come, first served basis, subject to these Campaign terms and conditions.

The participating Accounting Software Providers are as below:

- (a) E Stream MSC Sdn Bhd (SQL)
- (b) AutoCount Sdn Bhd (AutoCount)

3.2 The Bank will pay out a maximum total cash rebate of Ringgit Malaysia sixty thousand (RM60,000) for this Campaign, limited to one hundred fifty (150) Eligible Customers throughout the Campaign Period, on a first come, first served basis. After the total cash rebate of RM60,000 has been fully allocated, no further cash rebates will be given to the Eligible Customers even if they fulfil the qualifying criteria.

3.3 The Eligible Customer intending to participate in this Campaign shall proceed to :

- (a) communicate directly with the Accounting Software Providers for the subscription or purchase of the Accounting products and services and make payment in full to the relevant Accounting Software Providers at any time within the Campaign Period;
- (b) instruct the Accounting Software Providers to deliver a copy of the official receipt which contains information of the Eligible Customer’s company name, business registration number and the Accounting software package details to the Bank’s designated e-mail address at <[embmya@ocbc.com](mailto:embmya@ocbc.com)>.

The Bank will give the cash rebate to the first 150 Eligible Customers for which the official receipts are received by the Bank from the Accounting Software Providers, on a first come first served basis.

3.4 The cash rebate is non-transferable to any other party and not exchangeable for any vouchers, cash, or other items be it in part or in full.

3.5 The RM400 cash rebate will be credited to the Eligible Customer’s OCBC Business account/-i within 60 days after the bank receives the copy of official receipt.

3.6 Each Eligible Customer which fully complies with these Campaign terms and conditions can receive the cash rebate only **once** during the Campaign Period.

3.7 Any dispute in connection with the products and/or services purchased, subscribed and/or upgraded shall be referred to the respective Accounting Software Provider. The Bank disclaims all liability and responsibility



for any accounting software developed and owned by any third party or for any merchandise, products, and/or services paid for through or via the Accounting Software Provider.

- 3.8 To the fullest extent permitted by law, the Bank does not make and hereby expressly excludes and disclaims any representations or warranties with respect to the Accounting Software Providers and any products and/or services purchased from Accounting Software Provider. In particular, the Bank gives no warranty or endorsement, express or implied, written or oral, including but not limited to, any warranty of merchantability quality or suitability or fitness for any purpose in respect of the products and/or services purchased, subscribed and/or upgraded from Accounting Software Provider.

#### 4. General

- 4.1 The Bank may change any of these Campaign Terms and Conditions or to stop this Campaign, after giving prior notice by posting a general notice at the Bank's website and branches.
- 4.2 The Bank's decisions on any matter relating to this Campaign, including but not limited to the eligibility of any customer to participate in this Campaign, or whether any Eligible Customer has or has not fulfilled any Campaign requirements, the Bank's records as to the time at which the official receipt is received from the Accounting Software Providers, whether any Eligible Customer has fulfilled all the Campaign terms and conditions to qualify for the cash rebate, etc. shall be final, conclusive and binding on all parties.
- 4.3 The Campaign is governed by the laws of Malaysia.
