A. About the OCBC Business Debit Card (BDC)

No.	Question	Answer
1	What is the OCBC Business Debit Card?	The OCBC Business Debit Card is a payment instrument that allows you to withdraw cash and pay for goods and services.
2	How will the OCBC Business Debit Card benefit me or my business?	OCBC Business Debit Card allows you to: • ATM Cash withdrawal locally and overseas • Contactless purchase under RM500 • Better financial management by setting daily transaction limits • Simplified account overview via OCBC Velocity
3	What is the annual fee for OCBC Business Debit Card?	There is no annual fee for OCBC Business Debit Card. However, if it's a replacement card, RM12 will be charged.

B. Criteria for OCBC Business Debit Card (BDC) Application

4	Who can apply for the BDC?	 Open to new and existing OCBC MYR business current accounts Open only to Malaysia citizens who own a business including sole proprietors, partnerships, private limited companies (Sdn Bhd) and public limited companies (Berhad)
5	I am an existing eBiz customer, can I apply for BDC and how do I apply?	Yes, you can apply BDC by — • <u>Download</u> the Business Debit Card application form from the website • Complete the form • Authorised Person to walk into any OCBC Conventional branch to submit the application form (as Biometric is required)
6	I am an existing eBiz customer, is there annual fee charges on the BDC?	No. There is no annual fee charges on the BDC.
7	I do not have an existing OCBC business account, how do I apply for BDC?	Yes, you can proceed to – • Apply for an eBiz account online and sign up for business debit card via Online Self Help platform. • Fill up our appointment form, and we will be in touch with you.
8	There are more than two directors/partners in my business. Can I apply for more than one card?	Yes, you can apply up to 12 BDC Cards per OCBC Business account. Under one entity, each individual can only hold one card tagged to one account. Nevertheless, one entity can have max 12 cards tagged to different individual related to the entity.

10	What do I need to do if I want to cancel my BDC card?	Yes, you can perform card termination by – • Download the Maintenance form from the website • Complete the form • Walk into any OCBC branch to submit the completed form
11	What do I do after I received my new BDC?	Customer should call us at 603-8317 5200 to perform the self-activation. Alternatively, they may visit any OCBC Bank branch for manual activation.
