Placement/ Renewal	Premature Withdrawal	Placement Period	How much interest will be paid
RM10,000 on 1 March 2018 for 12 months at contracted rate 4.00% p.a. Maturity date: 1 March 2019	27 July 2018	Completed month = 1 March 2018 to 1 July 2018 (122 days)	RM10,000 x 4.00% p.a. x 122 days / 365 days x 50% = RM66.85
