1. Please opt for the right Statutory Declaration (SD) form for your OCBC Post Moratorium Financial Relief application.
2. The SD forms below are crafted based on the facility you have with the Bank, differentiated by the Entity (OCBC Bank (M) Berhad or OCBC AL Amin Bank Berhad), Type of Facility (Conventional or Islamic) and Reason of Applying (Loss of Job or Reduce of Income) .
3. Printing the correct SD form will help to smooth out your application process with the Bank.
4. Do note that it is compulsory for the form to be stamped by President of Sessions Court / Magistrate / Commissioners for Oath / Notary Public before it can be processed by the Bank as a complete application submission.
