# TERMS AND CONDITIONS

# Organizer & Qualifications

- The "<u>MyDebit Je and WIN</u>" ("Contest") is jointly organized by MYDIN MOHAMED HOLDINGS BERHAD (MYDIN) (Company No.: 199101011136 (221448-A)) and Payments Network Malaysia Sdn Bhd (Company No.:200801035403(836743-D)) (collectively referred to as "The Organizer").
- 2. The Contest is open to all MyDebit Automated Teller Machine ("ATM") card members issued by financial institution in Malaysia and must be a permanent resident in Malaysia or a Malaysian citizen who has a valid identification card during the Contest Period ("Participant").
- 3. The Participant must be 18 years old and above and have a valid account with any of financial institution in Malaysia and the account must be active with a good financial standing during the Contest Period until the redemption of prizes.
- 4. Individuals listed below are not eligible to participate in this Contest:
  - Employees of the Organizer [including its associates, subsidiaries or related thereto] and their immediate family members [children, parents, siblings, including spouses]; and/or

    - Note: Valid purchase worth RM100 and above (in a single receipt / transaction slip) will be given <u>ONE (1)</u> random serial number per entry (one entry per transaction slip regardless of the amount spent). (Note: serial number is for the Organizer reference/view only and will not be disclosed to the Participant).

# b) How to Participate (2): via Whoop! App (downloadable via Play Store and App Store)

i. Register in Whoop App (one-time registration).

ii. Click on the MYDIN "MyDebit Je and WIN" Contest banner.

iii. Each valid and complete entry must contain the following information:

- 1. Take a photo of the Proof of Purchase);
- 2. Answer the Contest question and provide the necessary info;
- 3. RETAIN: Proof Of Purchase (original).
- Participant will receive a reply message (Contest questions, privacy notice).
- <u>By submitting entries via Whoop! App, the Participant is deemed to have read and agreed to the privacy notice set forth in this Terms and Conditions.</u>
- Note: Valid purchase worth RM100 and above (in a single transaction slip) will be given
  ONE (1) random serial number per entry (one entry per transaction slip regardless of the

amount spent). (Note: serial number is for the Organizer reference/view only and will not be disclosed to the Participant).

13. Participant may send more than ONE (1) entry. Every ONE (1) transaction slip (with purchase of RM100 and above made using MyDebit ATM card) is eligible as ONE (1) entry. - 43. The Organizer reserves the right to amend the Contest Terms and Conditions at any time at its sole and absolute discretion.
- 44. In addition to these Terms and Conditions, any other order or rules of the Contest as stated at <u>www.mydin.my</u>or otherwise, shall also bind all Participant and their participation in this Contest.
- 45. In the event of any inconsistency between these Terms and Conditions and any terms contained in any promotional materials for this Contest, the terms contained at <u>www.mydin.my</u> shall prevail. If there is a conflict between these Terms and Conditions with the Malay version, the English version will prevail.

- 58. Any matter to the Personal Data relating to this Contest shall be governed by and dealt with in the Personal Data Protection Act 2010 and any relevant laws in Malaysia
