TERMS AND CONDITIONS

Organizer and Qualifications

1. “**Jom! MyDebit Je with Your ATM Card and Win**” is jointly organized by Tunas Manja Sdn Bhd (Company No: 198701007985 (166702-T)) (“**TMG**”) and Payments Network Malaysia Sdn Bhd (Company No: 200801035403 (836743-D)) (“**PayNet**”) [hereinafter collectively referred to as “The Organizer”].
2. The Contest is open to all MyDebit Automated Teller Machine [“ATM”] card holders issued by participating financial institution in Malaysia and must be a permanent resident in Malaysia or Malaysian citizen who has a valid identification during the Contest Period [“Participant”]. The Participant must be 18 years old and above and have a valid account with any financial institution in Malaysia and the account must not dormant and must be an active with a good financial standing during the Contest Period until the completion of the redemption of prizes.
3. Individuals listed below are not eligible to participate in this Contest:
 - Employees of the Organizer [including its associates, subsidiaries or related thereto] and their immediate family members [children, parents, siblings, including spouses]; and/or
 - Representatives, employees and /or the advertising agencies or promotional agencies of the Organiser [including its associated and related companies], and their immediate family members [children, parents, siblings, spouses].

6. Only payments/transactions made using MyDebit ATM card will be accepted for this Contest.

If for any reason this Contest is unable to proceed as planned for (and not limited) reasons such as computer virus, hacking, unauthorized intervention, fraud, technical failure, any acts of government not limited to movement control order or any other reason beyond the Organizer control, the Organizer reserves the right, in its sole discretion, to terminate, postpone, modify, extend or suspend this Contest at its sole and absolute discretion with prior notice.

 - Scan the QR Code and follow the browser instruction link to the Contest Website:

 - iii. Answer the Contest question and upload Proof of Purchase;
 - iv. RETAIN: Proof of Purchase (Original).
 - Participant will receive an acknowledgement message within 48 working hours of submission.
 - Each valid and complete entry must contain the following information:

 - ii. Clear image of Proof of Purchase.

14.
