Terms and Conditions

1. The Promotion

- 1.1. OCBC Bank Malaysia Berhad (295400-W) (“OCBC Bank”) and OCBC Al-Amin Bank Berhad (818444-T) (“OCBC Al-Amin”) present the OCBC Bank Catch-Your-Vouchers machine (“Promotion”) subject to these terms and conditions.
- 1.2. The Promotion runs from **13 July until 30 November 2019**, both dates inclusive (“Promotion Period”), and such other date(s) as may be determined at the sole and absolute discretion of OCBC Bank and/or OCBC Al-Amin, while stocks of the Prizes (as defined below) last.
